Re: Recommendation to Advocate in Support of AB-222 - *Enhancing Disability Rights and Access*

Dear Chair Friend and Members of the Board,

The purpose of this letter is to recommend that the Board consider advocating with State Legislators in support of *Assembly Bill 222 (AB-222) – Enhancing Disability Rights and Access* which proposes the formation of a workgroup dedicated to further improving disability access and rights.

The *Santa Cruz County Commission on Disabilities* is tasked with safeguarding accessibility and advancing the interests of Santa Cruz County residents living with disabilities. Santa Cruz County Code Chapter 2.72.060(J) mandates that the Commission “Review Federal and State legislation of interest to persons with disabilities and advise the Board of Supervisors of their recommendation” in fulfillment of their powers and duties. To that end, the Commission established an ad hoc subcommittee to review and recommend legislative priorities for 2023. On June 8, 2023, the Commission unanimously approved the subcommittee’s recommendation to prioritize AB-222 as one of four legislative priorities we would recommend that your Board consider formally supporting.

The Americans with Disabilities Act (ADA), signed into federal law in 1990, has been an invaluable beacon in ensuring accessibility and equality for individuals living with disabilities. However, we believe that these stipulations should serve as the minimum standard. The time is ripe for us to build upon this base and raise the bar higher.


AB-222 represents an important step in this direction. The formation of a 'Californians with Disabilities Workgroup,' as proposed in this bill, will give a platform to voices that can guide our legislature and administration in creating a Californians with Disabilities Act. This Act could advance disability access and rights beyond existing federal requirements.

Such a workgroup can provide invaluable insights drawn from lived experiences and professional expertise, helping to shape robust and effective legislation. It can enable California to lead by example, by creating a framework that other states may aspire to emulate.

We request that the Santa Cruz County Board of Supervisors advocate for AB-222 with our State Legislators. In doing so, you will demonstrate Santa Cruz County's commitment to improving disability rights and access, potentially setting a precedent for other counties in California to follow.

Re: Recommendation in Support of *AB-1029 - Advanced Healthcare Directive Form*

Dear Chair Friend and Members of the Board,

The purpose of this letter is to express our support for California *Assembly Bill 1029 (AB-1029) - Advanced Healthcare Directive Form* and to recommend that you consider formally supporting this important legislation sponsored by Assembly Member and former Santa Cruz County Clerk Gail Pellerin.

The *Santa Cruz County Commission on Disabilities* is tasked with safeguarding accessibility and advancing the interests of Santa Cruz County residents living with disabilities. Santa Cruz County Code Chapter 2.72.060(J) mandates that the Commission “Review Federal and State legislation of interest to persons with disabilities and advise the Board of Supervisors of their recommendation” in fulfillment of their powers and duties. To that end, the Commission established an ad hoc subcommittee to review pending legislation and recommend 2023 legislative priorities. On June 8, 2023, the Commission unanimously approved the subcommittee’s recommendation to include AB-1029 as one of four legislative priorities they recommend that the Board consider formally supporting on their behalf.

AB-1029 seeks to establish minimum standards for Psychiatric Advance Directives (PADs) which are a specific type of Advance Health Directive primarily designed to help individuals who may experience periodic or recurring crises as a result of their mental health disabilities. They offer an essential mechanism for these individuals to express their preferences for treatment and to designate trusted persons to make decisions on their behalf when they may not be able to do so during a mental health crisis.

In our society, invisible disabilities like mental health disabilities are often overlooked and people with these disabilities may not receive the same understanding and consideration as people with immediately apparent disabilities. Mental health disabilities are just as real and impactful as physical ones, and those living with these disabilities deserve the same level of care, respect, and autonomy over their treatment as any other individual.


There are countless residents in our county living with mental health disabilities, many of whom have experienced crises in the past that required medical intervention. For these individuals, PADs offer a means to maintain autonomy and control over their own treatment and care, even when they may not be in a position to communicate their wishes.

Under AB-1029, individuals living with mental health disabilities would be able to outline their preferred courses of action and appoint trusted individuals to ensure those preferences are upheld. This is of particular significance when dealing with mental health disabilities, as personal comfort and familiarity can often make a substantial difference in the efficacy of treatments and interventions.

We believe that the establishment of minimum standards for PADs, as proposed in AB-1029, is essential to ensure their proper use and implementation. It is also a significant step towards recognizing and addressing the unique challenges associated with mental health disabilities.

Therefore, we recommend that your Board consider sending a letter to Assembly Member Pellerin formally expressing your support for AB-1029. Thank you for your time and consideration of this important matter and for all you do on behalf of the disabilities community in Santa Cruz County.

Re: Recommendation to Advocate for *SB-445 – Special Education: Individualized Education Programs: Translation Services (Portantino)*

Dear Chair Friend and Members of the Board,

The purpose of this letter is to recommend that the Board consider advocating with State Legislators in support of Senate Bill 445 (*SB-445*) – *Special Education: Individualized Education Programs: Translation Services* (Portantino), a piece of legislation which proposes to establish timelines and revise standards for the translation of IEP materials and information.

The *Santa Cruz County Commission on Disabilities* is tasked with safeguarding accessibility and advancing the interests of Santa Cruz County residents living with disabilities. Santa Cruz County Code Chapter 2.72.060(J) mandates that the Commission “Review Federal and State legislation of interest to persons with disabilities and advise the Board of Supervisors of their recommendation” in fulfillment of their powers and duties. To that end, the Commission established an ad hoc subcommittee to review pending legislation and recommend 2023 legislative priorities. On June 8, 2023, the Commission unanimously approved the subcommittee’s recommendation to include SB-445 as one of four legislative priorities they recommend that the Board consider formally supporting on their behalf.

In 2017, former Commission on Disabilities Intern Angelica Victoria completed her Capstone project report entitled *Ven, vamos a platicar* (Come, Let's Talk) which assessed the challenges facing Latinx parents attempting to navigate the special education system. On its face, the IEP process can be challenging and intimidating to any parent trying to navigate it for the first time. Ms. Victoria’s study demonstrated that, with the added complexity that a language barrier presents, parents whose primary language was Spanish found it almost impossible to navigate effectively.

Santa Cruz County’s diverse population makes this bill of utmost importance. Approximately 34% of County residents identify as members of the Latinx community and many County school children have parents whose primary or only language is Spanish. In order for Spanish-speaking parents of children with IEPs to engage meaningfully in their children’s education and give them the best opportunity for academic success, the IEP must be presented to them in the language with which they are most comfortable and within a reasonable amount of time.

Parental involvement is vital to the success of students, particularly those living with disabilities, as it provides them with essential support, guidance, and advocacy throughout their educational journey. By actively participating in their child's education, parents can ensure that individual needs are met,

goals are achieved, and necessary accommodations are provided, leading to improved academic, social, and emotional outcomes.

Timely access to translated IEPs will empower parents to fully comprehend the content and implications of their child's education plan and enable them to actively participate in decision-making processes and advocate for their child's needs effectively. Translated IEPs can bridge the communication gap that often exists between schools and non-English-speaking parents of children with disabilities and foster stronger partnerships to ensure that the rights and needs of all students are effectively addressed.

Therefore, we request that you advocate with our State Legislators in support of SB-445. Your support would demonstrate the County's continued commitment to promoting inclusivity and equity within our county and protect the interests and educational opportunities for some of our most at-risk students.

Dear Chair Friend and Members of the Board,

The purpose of this letter is to recommend that the Board consider advocating with State Legislators in support of *Assembly Bill 1568 (AB-1568) – Developmental services: independent living skills services: rates*, a significant piece of legislation concerning developmental services and independent living skills services rates.

The *Santa Cruz County Commission on Disabilities* is tasked with safeguarding accessibility and advancing the interests of Santa Cruz County residents living with disabilities. Santa Cruz County Code Chapter 2.72.060(J) mandates that the Commission “Review Federal and State legislation of interest to persons with disabilities and advise the Board of Supervisors of their recommendation” in fulfillment of their powers and duties. To that end, the Commission established an ad hoc subcommittee to review and recommend legislative priorities for 2023. On June 8, 2023, the Commission unanimously approved the subcommittee’s recommendation to prioritize AB-1568 as one of four legislative priorities to recommend that your Board consider formally supporting.

As you may already be aware, the *Lanterman Developmental Disabilities Services Act* mandates the provision of independent living skills services for adult consumers to enable them to acquire or maintain skills for independent living or achieve greater independence. The current system, however, often falls short of providing the comprehensive and practical skills training necessary for the fullest possible independence.

AB-1568 offers a pragmatic and comprehensive solution. The bill proposes that independent living skills services should include functional skills training components such as cooking, money management, usage of medical and dental services, and community resource awareness. Furthermore, the bill advocates that these services should not be conducted in a center-based environment, fostering greater real-world applicability and integration.

Moreover, the bill calls for the revision and implementation of an equitable and cost-effective ratesetting procedure for state payment for independent living skills services. It ensures that such rates are not categorized as a community-based day program or adult day program and are set according to

the reasonable cost of these services, taking into account the most recent data from the United States Bureau of Labor Statistics' *State Occupational Employment and Wage Estimates for California*.

This bill presents a critical opportunity to enhance the living conditions of and prospects for adults with developmental disabilities within our county, fostering greater independence, personal growth, and community integration. This, in turn, benefits the community as a whole, allowing these individuals to participate and contribute to their fullest potential.

We therefore request that you advocate in support of this bill with our State Legislators. By doing so, you will be making a significant and tangible contribution to the lives of those within our community who most need our support.
