6.1. Strategic Action Planning

Commission reviewed the current Strategic Action Plan and discussed opportunities for collaborative efforts with other advisory bodies. A joint meeting with the E&D/TAC, Metro advisory committee (MAC) the RTC, Seniors Commission and the IHSS Commission to discuss affordable, accessible, transportation. Other topics such as affordable accessible housing and food accessibility for people with disabilities were also discussed. Motion to establish an ad hoc Collaborative Activities Subcommittee authorized to develop and implement an activity for the Commission to collaborate with community partners to address an issue of importance.

Daugherty reported that, during a first reading, all seven Santa Cruz City Councilmembers recently voted to remove the exception in the State's rent control statute that would have allowed the St. George to raise rents beyond the allowable limit. Should it be approved during the required second reading, it would take effect before the rent increase at the St. George was scheduled to take place. Daugherty will provide an update at the next meeting.
