Levinson reported that a Coastal Commission representative encouraged Commission to advocate for reopening the Rio Del Mar beach access pathways.

Levinson attended a County affordable housing presentation and followed up with Supervisor Friend to find out what percentage of the approximately 4600 proposed affordable housing units will be required to be ADA-accessible. Molina would like Planning to give the Commission an overview on how the affordable housing planning process works, including ADAaccommodation requirements, ratio of rentals vs. homes for purchase, etc..

Hi Kaite,

I hope you are well. Below is the news story and request for advocacy.

In early January, a truck pulling an excavator on a trailer collided with the Cabrillo College Pedestrian bridge of Soquel Drive. <u>Here is a new story with photos of the damage</u>. The bridge will need to be removed and replaced and the construction is planned to take up to two years to complete. The bridge pre-dates the ADA.

History of a Recent

The bridge was permitted back in 2021 for some updates that were completed in 2022. The project was approved to proceed without improvements to ADA accessibility. There are stairs to access the bridge on both sides of Soquel Drive and it has never been accessible. People with mobility disabilities must take elevators to the street level and cross at the crosswalk. This is not equal access and it is a problem that separates ambulatory people from the disabled community.

Request: Before the construction permit is approved, it is critical to equal access for all community members, that the bridge be made accessible to all people. Cabrillo College is built on a hill and traversing the two sides of campus should be the same regardless of mobility status. I request that the commission provide strong public comment on the need to make the bridge accessible before the permit is approved or before any new construction can begin. This is a Title II ADA requirement that should not be waived as it was when the refurbishment project was approved a few years earlier.

We need the planning commission to insist on the next iteration of the new bridge to be wheelchair accessible. No permit should be approved without a lens of inclusion and honoring the spirit of the ADA.

Copied is the proposal for developmental service changes budget proposal.. As a commission do we want to discuss and possibly ask the Supervisors to write a letter to Senator Laird and Assembly member Gail Perllerin advocating a restoration of the original funding? A delay of a year in increased care provider pay and inclusive preschool would have widespread and long lasting consequences to people with developmental disabilities.

The key major adjustments in the developmental services budget that the Governor is proposing in his 2024-2025 State Budget plan are (CDCAN will issue separate report on other proposals in the Governor';s budget):

- Regional Center Provider Rate Reform (-\$1 billion Total Funds, -\$612.5 million General Fund): Due to resource availability, returns full implementation of service provider rate reform to the original timeline of July 1, 2025, while maintaining focus on improving outcomes and quality of services through the Quality Incentive Program. That original July 2025 implementation date was moved up to July 1, 2024 in the 2022-2023 State Budget as part of the overall budget deal reached that year between the Legislature and the Governor. That implementation now is being proposed to go back to the original July 1, 2025 date. All rate adjustments and increases already implemented will remain in the budget and efforts to implement the Regional Center Provider Rate Reform will continue, though with the original July 1, 2025 implementation date (assuming the Legislature approves the Governor's budget proposal).

- Fairview Warm Shutdown (\$11.3 million General Fund): An additional year of funding to support the warm shutdown of Fairview Developmental Center as the property disposition process continues.

- Preschool Inclusion Grants (-\$10 million GF): Proposes to delay the grant program from FY 2024-2025 until FY 2026-2027.

The developmental services budget as proposed does not include any other major delays or reductions.

The Governor's release of his proposed spending plan begins the long yearly state budget process, with legislative budget subcommittee hearings beginning in February through late May; release in mid-May by the Governor of his May budget revision (that updates budget numbers and proposes revisions to his January 10th proposed budget) and then passage of budget plan in mid-June (state budget year begins July 1st)/.
