Re: Support for SB-239 (Arreguín) – Teleconferencing for Subsidiary Bodies

Dear Chair Hernandez and Members of the Board,

The Santa Cruz County Commission on Disabilities respectfully requests that the Board of Supervisors communicate support to Senator Arreguín for reviving SB-239, which would update teleconferencing rules for subsidiary bodies under the Brown Act.

SB 239 addresses a critical barrier to civic engagement by ensuring that people who cannot attend meetings in person due to mobility limitations, chronic illness, immuno-compromised status, transportation challenges, or caregiving responsibilities can continue to participate fully in local public processes. While emergency orders during the COVID-19 pandemic temporarily removed these barriers, many of our community members have since lost that access.

As a body charged with advising the Board on issues affecting people with disabilities, we have consistently heard from constituents who benefited from remote participation options. For many, the availability of teleconferencing has meant the difference between being able to serve or not applying for a seat at all. Even among our seated commissioners, ongoing disability-related barriers have made in-person attendance difficult at times. SB-239 would make it easier for commissions like ours—and others focused on aging and disability issues—to meet and operate effectively, ensuring that a diverse range of voices and lived experiences remain represented in local decision-making.

Supporting SB 239 aligns with Santa Cruz County's commitment to equity, inclusion, and accessibility. It advances the goals of universal design and removes structural obstacles to civic participation—especially for those who have been historically marginalized or underrepresented. The bill advanced through the Senate earlier this year but was placed on the inactive file in June. We urge the Board to advocate with the author to bring the bill back this session if possible, and if not, to encourage its reintroduction in the next session.

Thank you for your time and consideration on behalf of the disabilities community in Santa Cruz County. Please feel free to reach out should you require any further information or clarification.
