This essential role focuses on creating an inclusive environment where individuals with disabilities and functional needs can thrive.

### What Does a DAFN Coordinator Do?

**Ensures Accessibility:** Makes sure facilities and programs meet ADA standards and works to remove physical and systemic barriers.

**Plans for Emergencies:** Disasters don't discriminate, but their impacts often do. The DAFN Coordinator collaborates with emergency management teams to create plans that accommodate individuals with disabilities, ensuring shelters, transportation, and communication are accessible to all.

**Educates Others:** Trains staff and partners on disability inclusion and accessibility. These efforts empower county staff and community partners to better serve everyone.

**Engages the Community**: Building strong relationships is at the heart of the role. The DAFN Coordinator listens to residents, gathers feedback, and collaborates with local organizations to ensure services align with real-world needs.

### Why It Matters

Research indicates that individuals with disabilities are disproportionately affected during natural disasters. Studies suggest that they are two to four times more likely to die or sustain injuries in such events compared to those without disabilities. This heightened vulnerability underscores the critical need for inclusive disaster preparedness and response strategies. The DAFN Coordinator helps create a community where dignity, respect, and equity are for everyone—regardless of ability.

# Santa Cruz County Commission on Disabilities 2023 - 2024 Biennial Report

### 1. The Role of the Commission

The Commission on Disabilities is an advisory body to the Board of Supervisors on issues affecting persons with disabilities in Santa Cruz County. The Commission was established to:

- a. Review existing County policies that affect persons with disabilities and make recommendations to the Board of Supervisors regarding proposed changes;
- b. Review Sections 503 and 504 of the Federal Rehabilitation Act of 1973 and its implementing regulations and advise the Board of Supervisors on any actions necessary to bring the County into compliance with the Federal requirements and to eliminate discrimination against persons with disabilities;
- c. Review the provision of access for persons with disabilities to public places within the County and recommend improvements where needed;
- d. Review the County's Equal Employment Opportunity (EEO) Plan and policies and recommend to the Board of Supervisors and Equal Employment Opportunity Commission any revisions which may be necessary to eliminate employment discrimination against persons with disabilities;
- e. Review the County's Personnel rules and job descriptions and make recommendations to the Board of Supervisors and to the Civil Service Commission, as necessary, to assure that any unnecessary barriers to the employment of persons with disabilities are removed;
- f. Advise the Board of Supervisors on any other appropriate programs and actions which would increase employment opportunities for persons with disabilities;
- g. Evaluate services provided to persons with disabilities in the County and make recommendations to the Board of Supervisors based on their conclusions;
- h. Review requests by persons with disabilities or organizations for County assistance and advise the Board of Supervisors on appropriate actions;
- i. Investigate citizen complaints related to concerns of persons with disabilities and recommend appropriate actions to the Board of Supervisors;
- j. Review Federal and State legislation of interest to persons with disabilities and advise the Board of Supervisors of their recommendations; and
- k. Exercise other responsibilities related to the needs and concerns of persons with disabilities in the County.

### 2. Meetings Dates, Time, and Location

Commission on Disabilities meetings are scheduled for the second Thursday of every month except July and December, from 12:30 until 2:00 PM at County Government Center (701 Ocean Street, Fifth Floor Redwoods Conference Room, Santa Cruz).

In 2023, two regularly scheduled meetings were canceled for lack of a quorum.

In 2024, five regularly scheduled meetings were canceled for lack of quorum because of vacancies. At some points, the Commission did not have enough seated members to form a quorum even with 100% attendance. The Commission conducted a robust recruitment campaign to attract qualified applicants, but only one of their applicants was ultimately appointed despite all having been well connected in the disabilities community and meeting all qualifying criteria.

### 3. Commission Structure

The Commission on Disabilities is composed of ten voting members; two appointed by each of the five County District Supervisors. Commission officers are elected each year during the April regular meeting. On December 31, 2024, Commission on Disabilities membership was as follows:

### 6. Goals, Activities and Accomplishments

The Commission's activities and priorities are determined by the Commission's mandate, mission statement, and emerging needs as expressed by the community and identified by the Commissioners.

### **Mission Statement**

The Santa Cruz County Commission on Disabilities is a proactive advisory board that serves to ensure that children and adults with disabilities have opportunities to reach their maximum potential in independence, human development, productivity, and self-sufficiency, as well as to insure equity and access within the community.

### **Commission Objectives**

#### Objective 1:

To monitor, assess and advocate for the eradication of barriers and inequities impacting Santa Cruz County persons with disabilities.

<u>During the reporting period, Commissioners heard reports on the following community agencies, County programs, and other interested entities:</u>

 Santa Cruz County Parks recreational accessibility updates from Sarah Shea (Parks Superintendent) including creating an activity guide page specific to accessibility features, adding low-stimulus swim hours, increased mobility equipment and handrails, more accessible changing rooms, chairs, tables, and supplies like calming headphones. Shea also updated the Commission on how San Andreas Regional Center (SARC) grant funding helped to create supportive spaces and provide Swim Angelfish Adaptive Swim Training for staff to aid swimmers with disabilities. Parks also collaborated with the National Inclusion Project (NIP) for comprehensive assessments and training.

- Santa Cruz County Planning ADA-Accessible Housing Reports from Suzanne Ise (Principal Planner), Jim Heaney (Senior Building Plans Examiner), and Joanna Iruegas (Leasing Director for Mid-Pen Housing) on the County's process to ensure that new affordable housing developments include sufficient ADA-accessible housing units including minimum requirements, the permitting process, and the efforts that developers make to fill ADA-accessible units with residents who require ADA-accessible housing. Iruegas provided additional information about those efforts from the developer's perspective, including maintaining outreach distribution lists, web lists of available units, etc.
- County Law Enforcement Accommodations and Efforts for Individuals with Disabilities reports
  from Sargeant Ryan Kennedy and Lieutenant Ian Patrick summarizing the Officers Kennedy and
  Patrick on the CAREalert program (Creating Awareness, Responding Effectively) emergency
  response disability registry, Focus Intervention Teams, behavioral health ride-alongs, and
  specialized training provided to all Sheriff's deputies to increase their awareness and support
  effective engagement with community members with disabilities in crisis situations.
- Accessibility Support Center Advisory Committee

During the reporting period, the Commission engaged with, advocated for, and/or impacted public policy and programs in the following ways:

- Advocated with Santa Cruz METRO on accessible transportation issues including accessibility coordinator staffing, prioritizing people with disabilities during evacuations, ride scheduling barriers, and lack of sufficient space for wheelchairs on METRO buses resulting in people with wheelchairs at bus stops being passed by.
- Provided representation on the County's Housing Element Community stakeholder group to advocate for increased affordable, ADA-accessible, housing availability.
- Monitored County and supporting agencies' efforts coordinating a complex storm-related evacuation and disaster response during recent flooding events including the accessibility of the Code Red Registry for emergency notifications.
- Advocated in support of the *Vista Center for the Blind and Visually Impaired* Title VII grant application to the Older Individuals who are Blind (OIB) program. The program is offered by the Community Center for the Blind and Visually Impaired in partnership with the California Department of Rehabilitation.
- Advocated with the Board of Supervisors for funding and support for the placement of ADAaccessible beach mats on County beaches.
- Monitored Treasure Cove Accessible Playground development at Jade Street Park.
- Monitored the installation of accessible bathrooms at Hidden Beach County Park.
- Presented to the Equal Employment Opportunity Commission on disability employment awareness and equity.
- Provided feedback on the County's Equal Employment Opportunity and Cultural Competence Plan

- Monitored County revisions to legislation and policy impacting County Board of Supervisors advisory bodies.
- Monitored County Parks plans and subsequent cancellation of plans to provide programming at the Siltanen Park Pool.
- Advocated at the County's Affordable Housing presentation for increased ADA-accessible housing requirements in affordable housing developments.
- Supplemented Mid-Pen Housing's affordable housing unit outreach list with contact information for additional community partners who serve people with disabilities
- Monitored extreme rent hikes resulting from Santa Cruz City legislation and their impact on long-standing residents with disabilities residing in the St. George Hotel.
- Monitored Shared Adventures partnership with Simpkins Family Swim Center to provide free passes for residents with disabilities during low stimulation hours
- Monitored Santa Cruz County Park Friends' implementation of the ParkRx program in Live Oak
- Advocated for accessible elements during the San Lorenzo Park redesign.
- Advocated for Board Support for the City of Capitola's Jade Street Accessible Park.
- Participated in the CARES Justice Survey.
- Reviewed and advocated for 2023 State and Federal bills that would impact the disabilities community as identified by the California Senior Legislature (CSL) and Disability Rights California (DRC) including: AB-222 Civil rights Department: Californians with disabilities workgroup; AB-1029 Advance Health Care Directive Form Psychiatric Advance Directives; SB-445 Special Education: Individualized Education programs: Translation of IEPs (Individualized Education Plans); and AB-1568 Developmental services: Independent Living Skills Services: Rates.
- Consider opportunities for advocacy related to restricted public access to the only safe, accessible path of travel to Rio Del Mar Beach for people with mobility disabilities.
- Reviewed the accessibility of the Regional Transportation Commission's path-of-travel hazard reporting process.
- Monitored the availability and responsiveness of wheelchair repair services in the region.
- Monitored the Diversity Project's facility accessibility remodel.
- Monitored METRO's proposed route changes and the potential impact on seniors and people
  with disabilities in more rural areas, as well as students with disabilities who rely on public
  transit to attend class.

### **Objective 2:**

To promote the interests of Santa Cruz County persons with disabilities through community outreach and the provision of resources.

All Commission meetings during the reporting period were accessible, open to the public, and publicly noticed in accordance with Brown Act requirements to ensure that meetings were an open forum to both receive and provide information about matters impacting the local disabilities community.

### **Objective 3:**

### To monitor and promote equal opportunity employment for persons with disabilities in Santa Cruz County.

### <u>During the reporting period the Commission</u>:

- Reviewed new County postings for open positions and position descriptions.
- Provided feedback on the draft 2025-2027 County Equal Employment Opportunity and Cultural Competence Plan and monitored its progress towards publication.

### **Objective 4:**

To develop and implement special projects to advance the interests of persons with disabilities in Santa Cruz County.

During the reporting period, the Commission participated in the following special projects:

### • Recruitment of qualified candidates to fill Commission vacancies

During the reporting period, the Commission's primary efforts outside of regularly scheduled meetings was outreach to other connected community partners to raise public awareness of the many available seats on the Commission and the important work that the Commission does. The Commission's goal was to stimulate qualified, well-connected applicants to fill the vacancies and they were very successful in getting several applicants. Unfortunately, none of their applicants were appointed to the seats which remain vacant. All special projects were pended until the Commission had enough seats fill to meet regularly.

### • Commission History Project:

Although the Commission brought on a short-term intern to research the Commission's history, the project was pended until the vacancy crisis is resolved and the Commission is able to meet regularly again.

### <u>During the reporting period, the Commission established and dissolved the following ad hoc</u> subcommittees:

• Ad Hoc Public Awareness Subcommittee: The Ad Hoc Media Subcommittee became the Public Awareness Subcommittee, tasked with promoting public awareness of the Commission and disability issues. At the time of dissolution, the subcommittee members were Gutierrez Baeza, Taylor, Grijalva, and Daugherty.

### Ad Hoc Kudos Subcommittee:

Established to recognize community members and organizations that significantly advance equal access and opportunities for persons with disabilities in Santa Cruz County. At the time of dissolution, subcommittee members were Gutierrez Baeza, Daugherty, and Taylor.

### Ad Hoc Resource Directory Subcommittee:

Established to share community resources that support the interests of persons with disabilities in Santa Cruz County. At the time of dissolution, the only subcommittee member was Molina.

### Ad Hoc Accessibility Awareness Subcommittee

The Ad Hoc Accessibility Awareness Subcommittee is tasked with monitoring accessibility issues and recommending accessibility advocacy priorities to the Commission. At the time of dissolution, subcommittee members were Daugherty, Gutierrez Baeza, and Grijalva.

### Ad Hoc Legislative Advocacy Subcommittee

Established to monitor policy, legislation and budget decisions that impact the Santa Cruz County disabilities community and recommending legislative, policy and budgetary advocacy opportunities. At the time of dissolution, subcommittee members were Molina, Grijalva, and Haifley.

### • Ad Hoc Housing Subcommittee:

The Ad Hoc Housing Subcommittee is tasked with monitoring the availability of ADA-accessible, affordable housing in Santa Cruz County and recommending housing advocacy opportunities. At the time of dissolution, the only subcommittee member was Taylor.

### Ad Hoc Emergency Preparedness and Crisis Response Subcommittee:

The Ad Hoc Emergency Preparedness and Crisis Response Subcommittee is tasked with monitoring issues related to emergency preparedness and recommending resources and advocacy opportunities related to emergency preparedness and emergency response protocols. At the time of dissolution, subcommittee members were Taylor, Daugherty, & Molina.

### • Ad Hoc Voter Accessibility Subcommittee:

Established to monitor County voter accessibility efforts, liaise with the County's Voter Accessibility Advisory Committee, and recommend advocacy opportunities. At the time of dissolution, subcommittee members were Gutierrez Baeza, Grijalva, and Levinson.

#### Ad Hoc Recreation Subcommittee:

Established to monitor and promote participation in local recreational opportunities for residents with disabilities and to recommend advocacy and collaborative opportunities. At the time of dissolution, subcommittee members were Gutierrez Baeza and Molina.

### • Ad Hoc Commission History Subcommittee:

Established to develop a comprehensive Commission history exhibit and report described within the larger context of the disability rights movement to raise public awareness of the Commission's efforts and impact in Santa Cruz County. At the time of dissolution, the only subcommittee member is Daugherty.

#### Ad Hoc Collaborative Activities Subcommittee:

Established to develop and implement a collaborative special project with other related County Commissions and/or community partners to advance the interests of and remove barriers for Santa Cruz County residents with disabilities. At the time of this report, subcommittee members include Daugherty, Gutierrez-Baeza, Levinson, Molina and Taylor.

- Continue making recommendations as needed on public policy impacting the disability community in Santa Cruz County, particularly in the areas of health care; accessible housing; climate change adaptation and response; community resources; and digital accessibility and transparency;
- Continue to investigate advocacy opportunities for greater disability inclusion and representation in public policy impacting the disability community in Santa Cruz County, particularly in the areas of health care; ADA-accessible housing; climate change adaptation and response; community resources; the Master Plan for Aging; and digital accessibility and transparency;
- Continue education efforts and outreach to the community through hosting and attending events and sharing resources;
- Engage in active collaborative activities with related County Commissions and community partners as appropriate on matters of common interest to our shared communities;
- Continue to host the Semi-Annual Kudos Awards recognizing local individuals and organizations that advance the interests of persons with disabilities in Santa Cruz County;
- Continue developing a comprehensive Commission history for presentation/publication;

### In the coming year, the Commission on Disabilities recommends that the Board of Supervisors:

- Prioritize filling Commission on Disabilities vacancies with qualified Commissioners who are well-connected in the disabilities community;
- Support California Senior Legislature's proposed bill *SP-4: Ralph M Brown Act: Teleconferencing* (Senior Senator Stefan Lipson, El Cerrito, CA) authorizing teleconferencing with respect to county based Advisory Councils, Committees, Commissions, and their attendant Work Groups, Committees, and Subcommittees established for aging and disabilities issues in the same manner as it was during the Covid-19 Pandemic;
- Include ADA-accessibility and inclusion of people with disabilities <u>explicitly</u> in all County efforts to embed equity in Operational Plan goals and objectives, going beyond minimal accessibility requirements to consider and include functional accessibility;

- Require that a significant percentage of all affordable housing units in each approved development be ADA-accessible to allow County residents with disabilities an equal opportunity to obtain affordable housing;
- Prioritize and support the expansion of accessible, affordable transportation options and maintain and improve existing options;
- Continue to prioritize accessible recreational opportunities for both adults and children with disabilities;
