PK Hattis and photographer Shmuel Thaler	Sentinel reporters Aric Sleeper and PK Hattis and photographer Shmuel Thaler for many years have done a fantastic job of covering activities and events of the disabled community, and presenting them to the public with beautiful understanding and compassion using sensitive prose and imagery. There have been many stories, profiles, photos and photo essays sharing a side of the community that is not seen or in the consciousness of most citizens. The Santa Cruz community is lucky to have the opportunity to see and read about activities that reveal the lives—with the joy and struggle—of the disabled population. This has enriched the understanding of diversity in our community. The thoughtful press coverage these reporters and photographer provide leverages the efforts of non-profit organizations that try to reach out and provide services to this often overlooked segment of our population. The editorial management of the Sentinel should be recognized, as well, for supporting this awesome example of community journalism.
Mike Rockafellow	Rachael and Mike have done an incredible (volunteer) job for several years to manage the Challenger Little League program for Santa Cruz County. Not many people are aware of this component of the national Little League program which provides the opportunity for players with all disabilities and challenges to participate in a little league baseball activity. Rachael is the team/league coordinator, managing all the logistical functions of the league—from coordinating registration and ordering uniforms to training the announcers and running the snack shack. "Logistics" does not begin to capture the warmth and sensitivity Rachael brings to the program—her interaction with the families and every individual on the team are beautiful to watch. Mike is the head coach for the Challenger League, helping every kid do their best and feel they are having the experience of being a real baseball player. For many kids and families, their little league game is a highlight of their week, the kids having a classic baseball experience that is adapted to their special needs, having social time with peers and family, hearing cheers for their efforts, and the thrill of scoring home runs. The saying "they are all winners" is never more true than the Challenger League participants. It is clear that Rachael and Mike both have a love for the game of baseball and for the kids that are participating.
Erick Sturm	Henry, Andy and Erick have been leading the Shared Adventures archery program (on behalf of the Santa Cruz Archery Club) for over ten years. Their diligence, patience and expertise has enabled many individuals—of all ages and disabilities—to discover the joy of archery and experience the personal growth from participating in this sport. Henry, Andy and Erick have been a constant for the disabled community to have an opportunity to be trained to gain the self-awareness and self-confidence from participating in archery. These instructors have an incredible combination of sensitivity and seriousness that makes the archery activity a very meaningful experience. Countless times we have seen individuals come to their first archery class saying "I don't think I can do this" and an hour later, with a few target hits, feeling they are capable of taking on any challenge. This is a gift to the individuals and a gift to the world which these three instructors have taken on as a monthly mission in the most loving and selfless way.

	promoting disability rights—using her story to inspire and inform others.
	Beth's advocacy work is not just professional; it is deeply personal. She has advocated for both of her aging parents, navigating complex elder care systems with
	compassion and determination. She has lived in assisted living for over eight years, and in that time, she has led efforts to improve safety, cleanliness, and food
	quality for all residents—writing letters, meeting with staff, and driving positive change.
	During Disability Awareness Month, Beth helped educate her local community through public presentations at the Santa Cruz library—bringing visibility to the
